2. TERMS OF REFERENCE

DESCRIPTION: APPOINTMENT OF CONTRACTOR FOR THE EXTENSION OF BOUNDARY FACE BRICK WALL AND INSTALLATION OF CONCERTINA BARBED WIRE (Approx. 100m) AT FALCON GARDEN SITE WITH CIDB GRADING 1 GB (READVERT)

1. PURPOSE

The purpose of this Terms of Reference (TOR) is to appoint a qualified contractor for the extension of boundary face brick wall and installation of concertina barbed wire (Approx. 100m) at Falcon Garden Site with CIDB grading 1GB

2. BACKGROUND

Pikitup Johannesburg SOC (Pty) Ltd manages several operational facilities including garden sites used for waste drop-off and recycling activities.

At Falcon Garden Site, the existing boundary wall provides site demarcation and basic perimeter protection. However, the wall's current height and absence of adequate security topping pose safety and security risks, including unauthorised access and vandalism. The Facilities Management Department seeks to enhance security by increasing the wall height by 0.5m and installing a concertina barbed wire system.

3. SCOPE OF WORK

. Scope of Work:

The scope of works shall include, but not be limited to, the following:

- **2.1 Site Establishment**
 - Mobilisation of tools, equipment, and labour.
 - Health and Safety compliance setup and signage.
 - Setting out and protection of existing structures.
- **2.2 Wall Height Extension**
 - Carefully clean and prepare the existing wall surface.
 - Supply and lay new face bricks to extend the wall by **0.5m** for a **100m** length.

- Match existing brick type, colour, and mortar joints for uniform appearance.
- Allow for reinforced brickwork every fourth course using 75mm brick force.
- Provide proper curing and pointing to all joints.

- **2.3 Installation of Concertina Barbed Wire**

- Supply and install 450mm diameter galvanized concertina razor wire (3-loop type).
- Fix securely along the entire 100m wall using galvanized Y-angle brackets and tensioning wire.
- Ensure tight tensioning and neat installation for durability and safety.
- All fixings to be rust-resistant and compliant with SANS 675 standards.

2.4 Finishing and Cleaning

- Repair any damaged sections of the existing wall.
- Paint touch-ups where applicable.
- Remove rubble and waste from site.
- Demobilise and reinstate site to original condition.

- Compliance with all safety and workmanship standards.

6. Health, Safety, and Environmental Requirements:

- All workers to use appropriate PPE.
- Dispose of waste in accordance with environmental regulations.
