CONTRACT

INTERNAL APPEAL PROCESS

Following the adjudication of bids and selection of a preferred bidder, and provided that a procurement contract has not already entered into force, any bidder may submit a complaint in writing to the chairperson of the PIKITUP Board of Directors ("the Board") or the Managing Director that PIKITUP has not complied with the requirements of the PIKITUP Supply Chain Management Policy or the PIKITUP Code of Ethics, or has in any respect acted in a way that is irregular. The Chairperson of the Board or Managing Director shall not entertain a complaint unless it was submitted within 20 calendar days of when the supplier or contractor submitting it became aware of the circumstances giving rise to the complaint or of when that supplier or contractor should have become aware of those circumstances, whichever is earlier; or entertain a complaint after the procurement contract has entered into force.

Unless the complaint is resolved by mutual agreement of the bidder and the Chairperson of the Board or Managing Director, the Chairperson of the Board shall, within 30 calendar days after the submission of the complaint, issue a written decision. The decision shall state the reasons for the decision; and if the complaint is upheld in whole or in part, indicate the corrective measures that are to be taken.

The decision of the Chair of the Board shall, subject to the review powers of any competent court, be final.

TECHNICAL INFORMATION AND SPECIFICATION

1.0 SPECIFICATION

- 1) **The body of the portable latrine unit shall be strong, durable and rust proof, and made of either fibre glass, polyethylene, or approved similar.**
- 2) The toilet seat and flap of the unit shall be either plastic, approved chipboard, or approved similar.
- 3) The removable drum if required shall be a steel drum with sealed lid in accordance with the manufacturer of the unit.
- 4) All units shall be provided with two solid wood skids (or approved similar material) under the body of the unit. The skids shall be at least the length of the base of the units.
- 5) All units shall be of sound construction and any elements which have suffered any damage during manufacture or transport and handling (e.g. cracks or split corners), and elements that are warped or poorly formed may not be used and shall be removed from site.
- 6) One sample of the units shall be submitted to Pikitup before commencing with the contract and this sample when approved by Pikitup will form the quality norm for the contract.
- 7) The units shall comply with the following:-
 - Height not less than 2000mm
 - Width not less than 900mm
 - Depth not less than 1000mm
 - Capacity fixed tank not less than 200litres
 - Capacity removable tank not less than 200litres
 - Each toilet shall have adequate ventilation through gauzed openings, a locking mechanism that can be operated from the inside. It is the responsibility of the contractor to ensure that the toilet doors can be safely closed from the outside. No padlocks are allowed.

2.0 GENERAL:

- 1) Pikitup reserves the right to arrange alternative servicing of any latrine unit which the contractor has failed to service within the time stipulated on the RFQ document. All additional costs will be for the Contractor's account.
- 2) Servicing must include the pumping out and disposal of the contents as well as maintaining the units in a clean and sanitary state, to the satisfaction of 'P' representative. This will include the disinfection of the (external) area around the chemical toilet, on a distance of 1m from all corners of the toilet.
- 3) All Health regulations must be strictly complied with.
- 4) Disposal of the contents must take place at one of the Johannesburg Water Wastewater Treatment Plants or other designated points, and a certificate of safe disposal must be submitted information may be obtained from the Regional Manager.
