2. TERMS OF REFERENCE

REQUEST FOR QUATATION FOR THE APPOINTMENT OF SERVICE PROVIDER/S TO SUPPLY , DELIVER AND COMMISIONING OF MEDICAL EQUIPMENT (VISION SCREENER, AUDIOMETERS AND SPIROMETERS) FOR PIKITUP

2.1 Purpose

To request formal quotation from the potential service providers for appointment of a service provider to supply, deliver and commissioning of medical equipment (vision screeners, audiometers and spirometers) for PIKITUP that will be utilized for Medical Surveillance program for Pikitup employees.

2.1 BACKGROUND

Pikitup as a company is required to comply with applicable legal requirements related to the Occupational Health and Safety Act No 85 of 1993. One of the compliance requirements is that the company implements a Medical Surveillance programme to determine the health and the disease profile of its employees. The medical equipment should be of high quality and meet the required standards for medical equipment at an Occupational health setting. Pikitup has already implemented Medical Surveillance programme, which consists, amongst others, of the following medical screening tests:

- Vision screening
- Audiometry
- Spirometry

Pikitup Employee Wellness department needs to procure 12 Medical equipment (four each, Vision Screeners, Audiometers and Spirometers) for Pikitup. This equipment will mainly be utilized for the Medical Surveillance program for Pikitup employees.

2.2 SCOPE OF WORK

The appointed service provider will be required to supply and deliver the following medical equipment to Pikitup: Vision screeners (4), audiometers (4), and spirometers (4).

2.3 TECHNICAL SPECIFICATION AND REQUIREMENTS

2.3.1 KUDUWAVE/ EQUIVALENT AUDIOMETER FOUR (X 4)

These devices focus on boothless, portable technology for on-site, compliant testing.

- It allows simultaneous testing of both ears, enhancing efficiency and patient comfort.
- It must be designed for rapid, high-volume screening, particularly in occupational health setting.
- Must come with complimentary software for managing employee records and testing protocols
- The software must support cloud storage, ensuring data security and easy access.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
