TERMS OF REFERENCE

1. PURPOSE

The purpose of this Terms of Reference (TOR) is to appoint a qualified and experienced service provider with **CIDB grading 1ME** for the supply, delivery, installation, testing, and commissioning of new 12 000 BTU air conditioning units at Pikitup Johannesburg SOC (Pty) Ltd facilities namely:

- Selby Depot
- Randburg Depot

The project is intended to improve indoor working conditions, ventilation, and thermal comfort within identified office and operational areas

2. BACKGROUND

Pikitup Johannesburg SOC (Pty) Ltd requires the installation of new air conditioning units at Selby Depot and Randburg Depot due to inadequate cooling, aging systems, and operational requirements within office environments.

The appointed contractor shall provide complete turnkey installation services including electrical connections, refrigerant piping, mounting brackets, drainage piping, testing, and commissioning.

3. SCOPE OF WORK

The appointed service provider shall undertake the following works:

3.1 Supply of Air Conditioning Units

The contractor shall:

- Supply new 12 000 BTU split-type air conditioning units;
- Units shall be suitable for commercial office use;
- Units shall be energy efficient and inverter type where applicable;
- Units shall include:

- Indoor unit;
- Outdoor condenser unit;
- Remote control;
- Mounting brackets;
- Refrigerant piping;
- Electrical cabling;
- Drain pipes;
- Trunking and insulation.

3.2 Installation Works

The contractor shall:

- Install air conditioning units at designated areas within:
 - Selby Depot -20x
 - Randburg Depot- 5x
- Mount indoor and outdoor units securely;
- Install refrigerant piping and insulation;
- Install condensate drainage piping;
- Provide electrical connections from existing isolators or distribution boards;
- Provide trunking and cable management;
- Core drill wall penetrations where necessary;
- Test and commission all units;
- Ensure units are fully operational upon completion.

3.3 Testing and Commissioning

The contractor shall:

- Conduct pressure testing and gas checks;
- Test cooling performance;
