3. TERMS OF REFERENCE

3.1 SCOPE OF WORK

3.1.1 Purpose

The purpose of the scope is to appoint service provider will be required to provide auction services for movable items such as, but not limited to, furniture, electronics, appliances, heavy machinery and vehicles across all Pikitup facilities within the City of Johannesburg.

The appointed service provider will be required to provide the following services:

Pre compliance requirement: Registration with S.A Institute of Auctioneers Professional Body

3.1.1 Advertising and Marketing

- The auctioneer needs to advertise the auction in not less than two local newspapers distributing in the Johannesburg area, the auctioneer's website platform and the auctioneer's social media platform.
- The minimum size of the adverts in the newspapers must be at least an A6 size.
- The names of newspapers need to be mentioned before publishing.
- Submit advertisement draft for approval before publishing.
- Advertising to be placed in the newspapers seven (7) days before the auction date.
- Only the cost of the advertising in the two newspapers will be paid out of the proceeds\ from the auction.
- The auctioneer shall bear the costs related to the printing of signage boards and ensure the erection of same and shall bear the related costs, including advertising on the auctioneer's website and social media platforms.
- The auctioneer shall bear the costs of any other marketing and or advertising method used with the exception of the newspaper advertisement in the two newspapers what will be paid out of the proceeds from the auction.

3.1.2 Administration and services

- Auctioneer must administrate and control the entire auctioning process, for both physical auction and online auction.
- Auctioneer may only take bids from registered buyers at the auction.
- Security services of at least two (2) day guards and two (2) night guards per auction site for a period of twenty-one (21) days in total as instructed by Pikitup.
- Layout of lots in a prescribed, safe and accessible manner for viewing.
- **The clean-up of the various auction sites within one week after the auction date.**
- Submit a list of detailed lot groupings before the auction.
- Viewing will be two (2) days before the auction during normal business hours.

3.2 AUCTION SITES

Auctioning sites will be determined by Pikitup Johannesburg from all the Pikitup facilities.

3.3 DURATION OF CONTRACT

The duration of the contract is **twelve (12) months** from appointment date

4. EVALUATION CRITERIA

Proposals will initially be evaluated in terms of functionality criteria. The proposals that meet the functionality criteria will then be evaluated on price competitiveness and further evaluation will be based on the bidder's level of B-BBEE contributions, in terms of the Preferential Procurement Policy Framework Act using the 80:20-point systems.

The following criteria will be used for evaluating all proposals, where proposals must score a **minimum of seventy (70) points** for functionality to qualify for further evaluation.

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included).

- 2.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the **80/20** preference point system.
