2. TERMS OF REFERENCE

1. INTRODUCTION

The purpose of this Terms of Reference (ToR) is to outline the scope, specifications, and requirements for the execution of general building refurbishment works. The works will include plumbing, painting, ceiling installation, tiling, carpentry, electrical works, ironmongery, and metalwork as detailed in this document. The project aims to restore, upgrade, and ensure full operational efficiency and compliance of facilities in accordance with Occupational Health and Safety Act (Act 85 of 1993), SANS 1200 specifications, and municipal building regulations.

2. OBJECTIVE

To appoint a qualified and accredited contractor to execute the listed refurbishment and maintenance works to achieve:

- Functional and aesthetic improvement of facilities.
- Enhanced hygiene and safety standards.
- Compliance with relevant SANS building and plumbing standards.
- Prolonged life span of the existing infrastructure.

3. SCOPE OF WORK

The scope covers the following major trades:

3.1 Plumbing Works

The contractor shall:

- Supply and install **5 new close-coupled ceramic toilet cisterns** with dual flush mechanisms (Cobra/Lecico or equivalent).
- Supply and install **5 compatible toilet pans** (S-trap/P-trap as existing) with soft-close seat covers and wax seals.
- Supply and install **5 new chrome-finish stop valves and 15mm flexible connector hoses**.
- Safely remove and dispose of **5 existing cistern and pan units** in an environmentally compliant manner.
- Reconnect the water supply and soil system ensuring watertight joints and proper testing.
- Supply and use all necessary plumbing fittings and consumables (PVC fittings, T-connectors, sealants, brackets).
- Supply and install **1 “Cobra/Equivalent” Sink Mixer Swivel CP (Code: SE-970)**.

3.2 Paintwork

The contractor shall:

- Prepare all previously painted plastered, metal, and wood surfaces by cleaning, scraping, filling, and sanding as required.

- Apply:
One coat universal undercoat and two coats "**Plascon Velvagro/ Equivalent**" polyurethane enamel to internal and external walls (approx. **1242 m²**).
Paint ceiling areas (**85 m²**) using one undercoat and two coats "**Plascon Polvin Super Acrylic PVA/ Equivalent**".
- Ensure all paintwork matches the existing finishes and is done to the architect's specifications.

3.3 Ceiling Installation

The contractor shall:

- Supply and install **85 m² of suspended ceilings** not exceeding 1m below lightweight steel supports (OPS Manager's Office & Wellness Room).
- Install **0.5mm thick Donn Chromadek ceiling trim (85 m²)**.
- Paint ceiling surfaces as specified above.

3.4 Tiling Works

The contractor shall:

- Replace **150 m² of floor tiles** with 300x600mm Mazista "Silver Blue" slate tiles, fixed with tile adhesive and grouted with 4mm joints.
- Replace **9 m² of wall tiles** with 300x300mm mosaic tiles, sealed and grouted in white.

3.5 Carpentry Works

The contractor shall:

- Supply and install an **L-shaped kitchen sink unit cupboard** (4185 x 600 x 929mm + 1065 x 600 x 929mm) with drawers, shelving, ironmongery, and Formica top (sink installed elsewhere).
- Supply and install a **wall-mounted cupboard unit** (2521 x 300 x 800mm) with drawers, shelving, and ironmongery, all as per the architect's design.

3.6 Electrical Works

The contractor shall:

- Supply, deliver, and install **22 units** of 1200 x 600mm, 60W recessed LED panels with DALI modification.
- Include all fixing materials, mounting accessories, and electrical connections.
- Comply with **SANS 10142-1: Wiring of Premises** standards.

3.7 Ironmongery

The contractor shall:

Supply and install:

- **2 units** of DDC106601MK 66mm five-pin Euro-profile double cylinder locks (master keyed).
- **2 units** of PHT3901 exterior access lever handles.
- **3 units** of aluminium Venetian blinds (2.9m x 1.5m) and **4 units** (3.5m x 1.7m).

3.8 Metalwork

The contractor shall:

- Manufacture and install **steel cages** to protect outdoor air-conditioning units from vandalism and environmental damage, using:
- 156m of **50x50x3mm mild steel SHS frame**.
- 148m² of **expanded metal mesh (50x50mm, 3mm thick)**.
- **26 door frames, 26 lock systems, 26 hinge sets, 26 fabricated and installed units, 148m² anti-rust primer and powder coating.**
- Fabricate and install **1 heavy-duty double security gate** (1620x2066mm) with solid vertical round bars, lock box, and full priming and coating.

4. DELIVERABLES

- All installations fully functional and compliant with applicable standards.
- Surfaces properly finished, cleaned, and handed over in good condition.
- Completion certificate, testing reports, and photographic evidence of all completed works.
- Waste disposal certificates (for removed plumbing items).
- Guarantee period of **12 months** on workmanship and materials.
