GENERAL BUILDING REPAIRS & REFURBISHMENT WORKS – ZONDI DEPOT

CIDB GRADING - 1GB

1. PROJECT TITLE

Repairs, Refurbishment and Finishes: Painting, Flooring, Ceiling, Waterproofing, Blinds ,plumbing, and Door Locks – Zondi Depot

2. BACKGROUND

Pikitup Johannesburg requires the services of a competent and experienced service provider to carry out general building repairs and refurbishment works at Zondi Depot. The works include painting, wall finishing, floor finishes, suspended ceiling installation, plumbing work, roof painting/coating, waterproofing repairs, installation of Venetian blinds, and replacement of door locks to enhance the functionality, appearance, and safety of the facility.

3. PURPOSE OF THE APPOINTMENT

To appoint a contractor to supply, deliver, install and complete all required repairs and refurbishment works at Zondi Depot in accordance with specifications, applicable standards, and health and safety requirements.

4. SCOPE OF WORK (SPECIFICATIONS)

The appointed contractor shall provide labour, materials, tools, transport, supervision and equipment to complete the following:

4.1 Wall Painting (Washable Paint) – 1,200 m²

- Prepare surfaces (cleaning, sanding, filling cracks and imperfections).
- Apply 1 coat bonding primer/sealer where required.
- Apply 2 coats of high-quality washable interior/exterior paint (as applicable).
- All paintwork must be uniform and free from runs, patches, peeling or bubbling.
- Colour to be confirmed by the Facilities Representative.

4.2 Non-Slippery Floor Tiles – 420mm x 420mm

(Supply and Installation – area to be confirmed on site)

- Supply and install non-slip floor tiles (420mm x 420mm) suitable for high-traffic areas.
- Remove damaged tiles where applicable and prepare screed base.
- Use approved tile adhesive and grout suitable for commercial/industrial usage.
- Ensure correct falls (where relevant), alignment, and clean finishing.

4.3 Suspended Ceiling – 120 m² (Supply & Installation)

- Supply and install suspended ceiling system complete with:
 - Main tees, cross tees, hangers, bracing and accessories
 - Ceiling boards/tiles (e.g., 600x600mm or equivalent approved system)
- Ensure ceiling is level, secure, and neat.
- Contractor to allow for cutting and trimming around light fittings, vents, and services.

4.4 Waterproofing – 50 m²

- Identify leaking areas and remove damaged waterproofing material.
- Prepare substrate (dry, clean, smooth surface).
- Supply and apply waterproofing system (e.g., torch-on membrane or liquid waterproofing).
- Provide reinforcing membrane where required.
- Waterproofing works must include proper overlaps, sealing and finishing.

4.5 Supply & Installation of Venetian Window Blinds

Supply, deliver and install Venetian blinds complete with brackets and accessories for the following window sizes:

- 1.5m x 1.3m x 4
- 2.2m x 1.5m x 4

Requirements:

- Blinds to be aluminium or durable PVC suitable for office use.
- Must include side brackets, cords/controls, fittings and final adjustments.
- Installation must be straight, firm, and operational.

4.6 Supply & Installation of Mortice Locks (2 Lever) – Qty: 4

- Supply and install 4 x 2-lever mortice locks complete with:
 - Lock body
 - Matching keys (minimum 2 keys per lock)
 - Strike plate and accessories
- Ensure proper alignment, secure locking, and smooth operation.
- Make good any damage to doors/frames during installation.

4.7 Welding to Burglar Doors

- Weld burglar door to door frame and reinforce fixing points.

4.8 Light Fittings

- Supply and install LED 1.5m battens (minimum 22–30W).

5. Plumbing work - 2 additional toilets

5.1 Site assessment to confirm points of connection to existing water supply and sewer line

Supply and installation of 2 x toilet pans and cisterns sets complete

Water supply pipe installation to cisterns including isolation valves

Drainage installation using 110mm uPVC soil pipes including connection to main sewer line

Provide all connectors, bends, couplers, solvent cement, flexible hoses and fittings

Construct drywall partitions for 2 toilet cubicles including doors and locks

Making good: patching, sealing, finishing and cleaning of work area

Testing and commissioning: check for leaks, flushing, and drainage flow
