TERMS OF REFERENCE (TOR)

INSTALLATION OF OVERHEAD ELECTRICAL CABLE, PALISADE FENCING & STOREROOM STEEL CAGES WITH DOORS – SELBY DEPOT

CIDB GRADING - 1EB

1. BACKGROUND

Pikitup Johannesburg SOC (Pty) Ltd requires the appointment of a competent service provider to execute infrastructure improvement works at **Selby Depot**, including:

- Installation of overhead electrical cable to supply the Main Distribution Board (Main DB) over ± 250 metres
- Installation of 15m precast palisade fence
- Supply, manufacture and installation of steel cages and compartmentalized storeroom sections for secure storage, including steel doors, locks and security gates

These works are critical for operational continuity, improved security control, and compliance with electrical safety standards.

2. PURPOSE

The purpose of this TOR is to procure a suitably qualified contractor to provide materials, labour, supervision, tools and equipment to complete the described works in a safe, professional and compliant manner at Selby Depot.

3. SCOPE OF WORK

The contractor must perform all work required, including but not limited to the following three components:

3.1 Overhead Electrical Cable Installation (250m) – Supply to Main DB

The service provider shall:

A) Supply and Install Overhead Electrical Line

- Install overhead electrical cable from the source point to the Main DB over approximately 250 metres
- Supply and install:
 - Poles / supports (where required)
 - Cross arms, brackets, insulators, clamps
 - Cable saddles, tensioning equipment
 - Any required electrical protection accessories

B) Electrical Connections

- Connect the overhead line to the Main Distribution Board
- Ensure proper termination using correct lugs, glands, ferrules and isolators where required

C) Remedial & Compliance Requirements

- Provide all required:
 - Earthing and bonding
 - Surge protection devices (if required)
 - Cable identification labels
 - Danger signs and marking

D) Testing, Commissioning & Certification

- Test and commission the electrical supply installation
- Provide:
 - Electrical test results
 - Certificate of Compliance (CoC) by a registered person
 - As-built schematic updates (if applicable)

Note: Installation must comply with SANS 10142-1 and relevant electrical safety regulations.

3.2 Supply and Install 15m Precast Palisade Fence

The contractor must:

- Supply and install 15 metres of precast palisade fence
- Include:
 - Concrete posts
 - Palisade panels
 - Foundations / concrete bases
 - All accessories, fixing brackets, fasteners
- Ensure alignment, correct height, and stable foundations
- Make good all disturbed areas after installation

3.3 Supply and Installation of Storeroom Steel Cages and Compartmentalization

The contractor shall supply, fabricate and install steel cage partitioning within the storeroom.

A) Cage System Requirements

- Total storeroom coverage area: $\pm 400\text{m}^2$
- Divide the storeroom into 6 lockable compartments
- Each compartment must include:
 - 3 steel shelves
 - Secure cage partitioning panels
 - Numbering/signage per compartment

B) Material & Construction Standard

- Cages must be manufactured using:
 - Heavy-duty welded steel mesh panels OR steel bars
 - Robust steel frame (angle iron / square tubing)
- Minimum requirements:
 - Anti-corrosion protection (galvanised or epoxy coating)
 - Smooth finishing (no sharp edges)
 - Anchored to floor and wall structures for stability

C) Doors and Access Control

Supply and install:

(i) Double Steel Doors

- 5 x Steel double doors
- Each door must include:
 - Heavy-duty hinges
 - Complete lockset
 - Padlock hasp (if required)
 - Steel door frame

Each double door must also include an external/internal security gate.

(ii) Single Steel Doors

- 6 x Steel single doors
- Each door must include:
 - Complete lockset
 - Steel frame
 - Heavy-duty hinges

Each single door must also include an external/internal security gate.

D) Security Gates Requirements

Security gates must:

- Be manufactured from heavy-duty steel
- Include locking mechanism (padlock lockable / mortice lock)
- Open outward/inward as per site configuration
- Be fitted with anti-tamper hinges and lock protection

3. Completed installations as per scope
4. Electrical test reports and commissioning results
5. Electrical Certificate of Compliance (CoC)
6. Practical completion handover report

- Be secure, tamper-resistant and durable
- Include all finishing, sealing and making good where required

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement

- between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. 5. BID TERMS AND CONDITIONS

1. **The Lowest or any bid will not necessarily be accepted** and the **PIKITUP reserves the right not to consider any bid** not suitably endorsed or comprehensively completed as well as the right to accept a bid in whole or part.
