2. TERMS OF REFERENCE

DESCRIPTION: PROVISION FOR ONCE-OFF PEST CONTROL SERVICES AT ALL PIKITUP DEPOTS, LANDFILL AND GARDEN SITES

1. BACKGROUND

Pikitup Johannesburg SOC (Pty) Ltd is the official waste management entity of the City of Johannesburg Metropolitan Municipality, responsible for providing waste collection, landfill management, garden site operations, and environmental upkeep across the city's seven regions.

In line with its commitment to environmental health, hygiene, and safe working environments, Pikitup seeks to appoint a qualified pest control service provider on a once-off basis to undertake comprehensive pest-control treatment and installation services across all Pikitup depots, landfill sites, and garden facilities. These sites handle domestic and commercial waste daily, creating a high-risk environment for rodents, cockroaches, flies, and other pests that pose health, safety, and environmental hazards if not adequately controlled.

2. PURPOSE

The purpose of this Terms of Reference is to outline the scope, objectives, and deliverables for the provision of once-off pest control services at all Pikitup operational facilities to:

- Eliminate and prevent infestations of rodents, cockroaches, flies, and mosquitoes.
- Improve hygiene and environmental conditions in line with OHS and Environmental regulations.
- Protect Pikitup employees, visitors, and the surrounding communities from vector-borne diseases.
- Ensure compliance with municipal environmental health standards and the **Occupational Health and Safety Act (Act 85 of 1993)**.

3. OBJECTIVES

The objectives of this once-off pest control project are to:

- Conduct a site-wide pest risk assessment and inspection.
- Install pest-control equipment, including rodent bait stations, fly traps, and cockroach gel points.
- Apply eco-friendly chemical treatments in all high-risk and infestation-prone areas.
- Provide a detailed completion report with maps showing treatment coverage and installed devices.
- Ensure compliance with SANS 10133 and Environmental Management Act (Act 107 of 1998).

4. SCOPE OF WORK

The appointed service provider shall be required to perform the following activities at all Pikitup Depots, Landfills, and Garden Sites:

4.1 Site Inspection and Assessment

- Conduct an initial site survey to identify pest activity zones, entry points, and breeding areas.
- Prepare a pest risk assessment report before commencement of treatment.

4.2 Treatment Activities

- **Rodent Control:** Supply and install lockable, tamper-proof bait stations every ± 20 metres around perimeter walls, offices, and waste storage zones.
- **Cockroach and Ant Control:** Apply gel baits, residual spray, and insect growth regulators in kitchens, changerooms, and ablution facilities.
- **Fly and Mosquito Control:** Install fly traps and apply suitable larvicides around drains, skips, and leachate areas.
- **External Spraying:** Apply residual insecticide around perimeter walls, bin storage areas, and waste bays.
- **Mapping and Labelling:** Mark all bait station and trap positions on a facility layout plan.

4.3 Equipment and Materials

- All materials and chemicals must be approved by the Department of Agriculture, Forestry and Fisheries (DAFF).
- The use of environmentally friendly, biodegradable, and low-toxicity products is mandatory.
- All chemical substances must be supplied with Material Safety Data Sheets (MSDS).

5. DELIVERABLES

The service provider must deliver the following outputs:

1. Pre-treatment inspection report for each site.
2. Supply and installation of pest-control devices (bait stations, traps, gels).
3. Application of treatment chemicals in identified infestation zones.
4. Post-treatment report including:
 - Number and location of devices installed.
 - Chemicals used and quantities.
 - Observed infestation trends and recommendations.
 - Photographic evidence of completed work.
5. All works to be completed within 30 calendar days of appointment.

6. HEALTH, SAFETY & COMPLIANCE

- All pest control staff must be registered with SAPCA (South African Pest Control Association) and possess valid P-number certification.
- The service provider must comply with:
 - **Occupational Health & Safety Act, 1993 (Act No. 85 of 1993)**
 - **Hazardous Chemical Substances Regulations**
 - **Environmental Management Act, 1998 (Act No. 107 of 1998)**
 - **SANS 10133 – Pest Control Practices**
- Appropriate Personal Protective Equipment (PPE) must be used during all operations.

7. REPORTING & QUALITY CONTROL

- The service provider shall report to the Facilities and Security Management Unit of Pikitup.
- Progress and completion reports must be submitted to the General Manager: Facilities and Security.
- Random inspections will be conducted by the Facilities Department to verify quality and completeness.

8. DURATION

This is a once-off project, expected to be completed within 30 days of the official appointment and site handover.
